**Professor Lelia Green** is Professor of Communications and Associate Dean, Research and Higher Degrees in the Faculty of Education and Arts, Edith Cowan University. Author of *Technoculture: from alphabet to cybersex* (Allen & Unwin 2002), Lelia is currently writing a book on *The Internet*. She has authored or co-authored more than seventy refereed papers and has served on the editorial boards of Media International Australia and the Australian Journal of Communication. She is one of the 'Australia .au' authors for the *Digital Review of Asia Pacific*.

In addition to her work with the ARC Discovery Project which led to this Workshop: *Australian responses to the images and discourses of terrorism and the other: Establishing a metric of fear*, Lelia is a Chief Investigator with the ARC Centre of Excellence for Creative Industries and Innovation, and is (or has been) first Chief Investigator for three ARC Linkage projects (two in online community, with the National Heart Foundation; the other with the Public Transport Authority, WA), and a past Discovery project looking at the Internet in Australian family life. She has published articles in various areas of interest including the historical representation of Muslim women in the media; racism, fear and Australian identity; the fear of terrorism; Australian Muslim identity; conceptualisations of ethnicity in research; citizenship; secularism and religious minorities and political fear.

She is currently Post Doctoral Research Fellow at the Centre for Applied Social Marketing at Edith Cowan University and has previously occupied senior policy positions in government. Anne is also current President of Dar al Shifah Islamic Inc., a volunteer organisation that offers services to the community and to government. ## Exploding Media Myths: Misrepresenting Australia?

How do the Australian media represent Australia and Australians? Every image, every news segment and every interview we see or hear is mediated by news professionals, journalists, advertisers and public relations practitioners. But what has this mediation led to? Are we a more relaxed, content and confident nation, or one gripped by anxiety and fear — about mortgage rates, climate change, terrorism, immigration and even how we eat, dress, live and garden?

It was only in the 1920s - according to the Oxford English Dictionary - that people began to speak of 'the power of the media'; but people use the expression for good reason. media and power are closely related.

"Surviving terrorism: Negotiating the media"


Professor John Tulloch is Research Professor in Sociology and Communications at Brunel University, West London, and is the author of numerous academic books and articles in the field.

He is also a survivor of the 7 July 2005 London bombings and his picture was flashed around the world as he emerged, injured, from Edgware Road Underground Station and, subsequently, being visited by HRH Prince Charles in a UK hospital.

John is uniquely placed to address his chosen keynote topic. A past Head of School for Journalism, Media and Cultural Studies at Cardiff University, Wales, John went on to be Director of the Centre for Cultural Research into Risk at Charles Sturt University, NSW, prior to taking up his position at Brunel.

John is an Australian citizen and lived in Australia for 25 years.

His book, *One Day in July: Experiencing 7/7* was published by Little, Brown Book Group in 2006.
